## REQUIRMENTS

### ....FOR TOURISM

- ♦ One Fully, Correctly & Clearly, Completed Visa Application.
- ♦ A Passport, valid until at least Six Months plus Photocopies of first two pages.
- ♦ Two Passport-size Photographs.
- ♦ A Confirmed Returned Airplane Ticket. / TRAVEL ITINERARY.
- ♦ Recent Bank Statement.
- ♦ Hotel Reservation and Fax Intimation to the Embassy (Attention: Consulate Section Fax # 2279552) by the hotel concerned confirming your stay in Egypt.

### .... For Business Meeting/Conferences:

- ♦ One Fully, Correctly & Clearly, Completed Visa Application.
- ♦ A Passport, valid until at least Six Months plus photocopies of first two pages.
- ♦ Two Passport-size Photographs.
- ♦ A Confirmed Returned Airplane Ticket. / TRAVEL ITINERARY.
- ♦ An Invitation, from the Inviting Egyptian Company, should Fax directly to The Consul General, Egyptian Embassy, Islamabad, mentioning the duration and period of your intended stay.
- ♦ Recent Bank Statement.
- ♦ Hotel Reservation and Fax Intimation at Fax # 2279552) by the hotel concerned confirming your stay in Egypt.

### Attention Visa Applicants:

- ♦ Applications and required Documents should be submitted at least 02 week before the intended departure date.
- ♦ Applicants are requested to appear in person to submit the applications.
- ♦ Passports may be collected by a third person.
- ♦ The Embassy may request additional information and/or documents at any time.
- ♦ All fax messages/letters pertaining to visa matters should be addressed to; THE CONSULAR SECTION, Fax No. 2279552.
- ♦ Applicants must specify immediate contact number or mobile number in case an interview is required or an additional document is needed.
- ♦ The Consular Section takes no responsibility if a passport/document is not collected within TWO Weeks time after the issuance of visa receipt.
- ♦ Supplying the documents does not automatically guarantee that the visa will be granted.
- ♦ Consular Section Working hours are from Monday to Friday, 10:00 h to 12:00 h and Collection of passports and documents: Monday to Friday, 02:30 h to 03:30 h only.

### Currency Regulation:

- ♦ It is allowed to all passengers (whether Egyptians or Foreigners) arriving or departing from Egyptian Air or Sea ports or other entry/exit check points to carry in cash no more than 10,000 US\$ or equivalent amount in any other foreign currency. Further more, passengers may carry no more than 5,000 Egyptian Pounds.
- ♦ Any amounts of Foreign or Egyptian Currency exceeding the above-mentioned amount, should be declared at the Egyptian Customs Authorities, otherwise these extra amounts will be confiscated and the bearer will be subject to legal procedure under the law of prohibition of money laundering.
