#### Tourist visa requirements:

- Passport must be valid for six months (single entry), 18 months (Multiple)
- Passport copy first two pages
- Two visa application forms
- Return/onward ticket
- Reference letter from your employer/office addressed to Consular/Visa Officer mentioning your job, duration of service and detail of visit purpose. In case of businessmen, please attach your business documents.
- Diplomatic note / recommendation letter from their respective Consulate or Embassy (Non Pakistani)
- Pak Visa Copy (Non Pakistani)
- 3 recent passport size photographs
- Bank Statement of the last 6 months, with the minimum balance equal to \$2000/-.
- Copy of CNIC
- Confirmed hotel reservation.
- Itinerary (original/copy) or a letter from travel agents, airline, steamship company, confirming the purchase of tickets into and return from Indonesia (Note: the Visa Officer may ask the copy of the original airplane ticket).
- Authority letter on company's letter head for submission in the consulate in the name of \_\_\_\_\_\_\_.
- Visa Fee: Transit Visa \$ 20, Single Entry \$45-; Multiple for 1 year \$100/-

Service charges Rs. 500/-

Temporary Stay Visa: Six Months US \$ 50, One Year US \$ 100, Two Year US \$ 175 Service charges Rs. 500/-
